### TERMS AND CONDITIONS

1. Bitcoin Wallet is provided and released for Review

Once the Bitcoin wallet is provided, it is reviewed to ensure
that it is accurate and functional. This review is important
to avoid subsequent transaction errors
and ensure a smooth process.

2. Lawyer-to-Lawyer Meeting on Proof of Capital and Satoshi Test

As part of the meeting between the lawyers of both parties the buyer provides proof of capital. At the same time, the seller must carry out the so-called Satoshi test together with their lawyer. This involves the buyer transferring bitcoins to the seller via the wallet ID provided and then immediately transferred back by the seller. This serves to ensure that the seller actually has access to the specified wallet.

## 3. Contract Signing and Purchase Processing

The contract can optionally be signed physically on site in Vienna, Austria, with our escrow lawyer to finalize the purchase together.

The buyer pays the agreed purchase price into the escrow account after this has been officially confirmed and verified by the seller himself. The seller then sends the bitcoins to the escrow agent's wallet.

At the same time, the escrow lawyer transfers the amount to the seller's account.

The large sums of money are of course insured by the escrow lawyer, ensuring a 100% guarantee between both parties. It is possible to receive the funds alternatively in USDT (Tether) or in fiat currency, depending on your individual preferences and requirements.

#### WHAT DOES COMMISSION REPRESENTATION GENERALLY LOOK LIKE?

As a rule, we pay out 50% of our revenue for each purchase transaction.

of which 50% is paid out to the seller. For the payout, there is a so-called "Payout-Master"
on the buyer's side who completes this payout request:
