

SourceWeb-Exchange Reseller Compensation Plan:

Exchange Rate Optimization in Bolivia

Introduction:

The SourceWeb-Exchange offers channel Partners an attractive opportunity to generate revenue through the mediation of Customers. As a Sales-Partner, you benefit of a clearly structured and lucrative remuneration model.

The minimum deposit to make the effort meaningful is 100 USD, Euros, Swiss Francs or British Pounds.

Compensation Details:

1. Commission:

- **Amount of Commission:**
Distributors receive **20% Commission** on every transaction, who make their referred Customers.
- **Calculation of the Commission:**
The 20% is based on the Service-Fee that SourceWeb-Exchange of the respective transaction.

2. Payout:

- **Cycle:**
Commissions are paid monthly.
- **Minimum Withdrawal Amount:**
Commissions are paid from an amount of **100 EUR/USD/GBP/CHF** .
If the amount is lower, it will be carried over to the next month.
- **Withdrawal Methods:**
 - Wire Transfer
 - PayPal
 - Cryptocurrencies
 - Cash

3. Customer and Transaction Tracking:

- **Note on the First Order and Placement Assignment.**
When placing the first order or deposit, the Buyer enters via the following links: <https://pay-usd.sourceweb.cloud> or <https://pay-euro.sourceweb.cloud> in the field "Facilitator of this Deal".
This information is necessary so that we can assign the Buyer to the appropriate intermediary. This ensures that the referral commission is correctly credited to the intermediary. After this initial assignment, the information is stored and the intermediary will automatically receive the commission for all further orders in the future or deposits made by the buyer. Please make sure that the name is correct and complete to ensure a smooth process.

Note on Attribution for Deposits Outside the Links provided.

If the deposit is made outside of the above links, it is sufficient to if the intermediary informs us via our Business-WhatsApp, that the Buyer comes from him.

The information can be easily shared via our WhatsApp number +44 7858 827 067. Please provide the relevant details, to be able to carry out the assignment correctly.

In this case, too, the assignment is stored and the intermediary receives in the future, the Brokerage-Commission for all further orders will automatically be paid or deposits made by the buyer.

We ask you to ensure that this information is provided in a timely manner, so that a smooth assignment can be ensured.

4. Requirements for Distributors:

- Registration: Distributors must register via the following Link: <https://sw.direct/contract/swe/en/>
- Contract: An Official Distribution-Agreement must be signed to ensure that all Parties understand and comply with the terms.
- Compliance with Guidelines: Resellers agree to conduct advertising and distribution methods in accordance with SourceWeb-Exchange's guidelines to ensure that all customers are advertised in a legally and ethically correct manner.

5. Example Calculation**Note on the Calculation of the Transaction-Fee.**

The Transaction-Fee is calculated individually and depends on the amount of the deposit. The exact exchange rate and the sum that the Buyer will receive will be agreed directly with the Customer.

A difference of at least 20% of the Deposit-Amount remains as profit at SourceWeb. This percentage represents the minimum amount that SourceWeb will remain as revenue from the transaction.

Please note that individual arrangements are possible depending on the deposit amount and conditions. For any further questions or details about the Agreement, please do not hesitate to contact us.

A Customer you refer makes a transaction with a \$500 Transaction Fee.

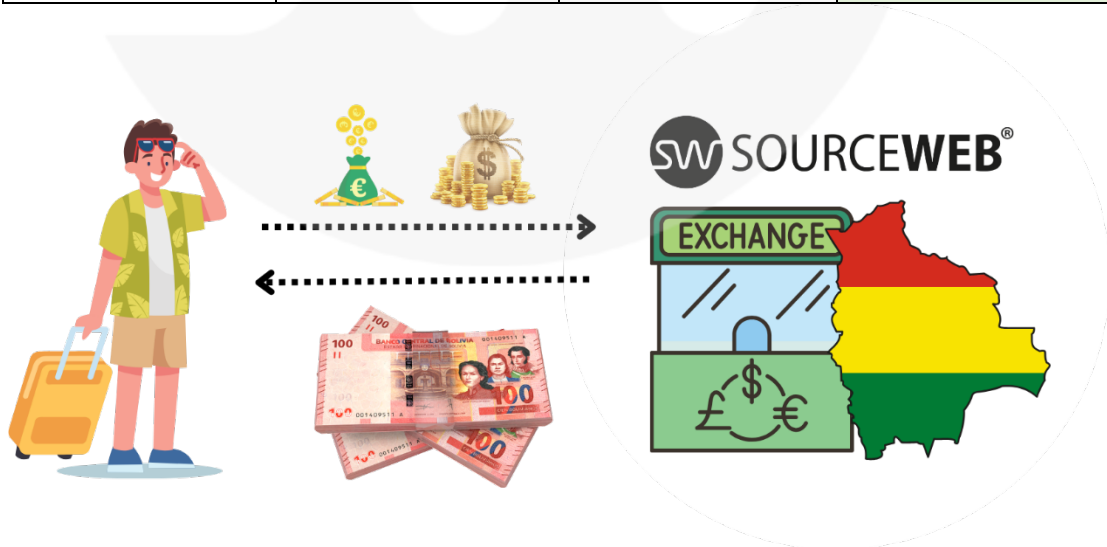
Your Commission: 20% of \$500 = \$100.

If you have multiple customers and higher transactions, your Commission will increase accordingly.

As a rule, the same Customer will continue to make further deposits with us on an ongoing basis.
 This ensures that all future transactions are also processed according to the agreed terms.
