The following contract is concluded:

Introduction

This Agreement governs the commission agreement between SourceWeb-Exchange (hereinafter referred to as "SourceWeb") and the Sales Partner (hereinafter referred to as "Partners") in connection with the referral of Customers for exchange rate optimization in Bolivia.

§ 1 Obligations of the Partner

(1) The Partner undertakes to actively refer Customers to the Company's services to advertise. He will ensure that all information and promotional activities are accurate, ethical and in line with the company's policies.

§ 2 Remuneration Regulations

(1) Commission: The Affiliate receives 20% commission on the service fee, that the company receives from Customers referred by the Partner.

(2) Conditions: The Commission is only applied to successful and completed transactions that can be clearly assigned to the Partner.

§ 3 Payment of the Commission

Cycle: The Commission is paid monthly.

Minimum Amount: If the Commission is less than 100 EUR/USD/GBP/CHF, the amount is carried over to the next billing period.

Methods: Withdrawal is made via bank transfer, PayPal, Cryptocurrency or Cash Payment.

§ 4 Tracking and Assignment of Customers

(1) This Agreement shall enter into force upon the registration of the Partner and shall remain valid, until it is terminated in writing by one of the parties.

(2) Both parties may terminate the contract at any time with a notice period of 30 days in writing.

§ 5 General Provisions

(1) Liability: The Company accepts no liability for any loss or damage, that arise from the partner's actions.

(2) Confidentiality: Both parties undertake to disclose all confidential information, exchanged under this Agreement.

§ 6 Acceptance of the Contract

By signing this Agreement, the Affiliate agrees to the above terms.

§ 7 Applicable Law

This Agreement is governed by the law of the country in which the Company is headquartered. The place of jurisdiction is London.

§ 8 Formal Requirement

There are no side agreements to this contract. Amendments and additions are only valid if agreed upon in writing. Writing also includes signatures with a digital signature (DocuSign). This formal requirement also applies to any changes to this written form requirement.

§ 9 Severability Clause


Should individual clauses of this contract prove to be invalid, the legal validity of this contract shall not be affected by this in all other respects. The invalid clause shall be replaced by a clause that comes closest to what is economically wanted.

The same applies to any existing loopholes in the contract.
